Articles of Amendment (Non-Profit)

To the Secretary of the State of the state of Idaho

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends its articles of incorporation as follows:

1. The name of the corporation is Pocatello Christian School, Incorporated.
2. The text of each amendment is as follows:

Article 2: Pocatello Christian School is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue law), including, but not limited to:

- 2.1.1. Pointing children and adults to a trusting relationship in the Lord Jesus Christ, which trust brings eternal salvation.
- 2.1.2. Training children and adults in the application of Biblical ethics to character development in everyday life.
- 3.1.3. Providing children an academic education that excels and prepares those children to succeed as profitable citizens.


Article 8: In the event of the dissolution of the Pocatello Christian School, a non-profit corporation organized along fundamental, Baptist principles, the assets of this school shall be given to Pocatello Baptist Church of Pocatello Idaho, a non-profit incorporation formed in the state of Idaho. In the case of the previous dissolution of Pocatello Baptist Church, the assets shall be distributed to another independent, fundamental church which is local to Pocatello, and duly organized as a non-profit corporation of the state of Idaho, as agreed upon by a majority vote of the current School Board.

3. The date of the adoption of this amendment was October 29, 2006.
4. Since Pocatello Christian School is a corporation without members, the amendment was adopted by a unanimous vote of the board of directors.
