## RECERVED ARTICLE OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is B.J. BARNES & SONS TRUCKING, INC.
  - 2. DURATION: The period of it's duration is perpetual.
  - 3. PROFIT: This is a profit corporation.
- 4. <u>PURPOSES:</u> The purpose or purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- 5. SHARES AUTHORIZED: The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1000) shares of no par value common stock.
- 6. PRE-EMPTIVE RIGHTS: Shareholders shall have pre-emptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
