KNOW ALL MEN BY THESE PRESENTS that DONALD SCHLUETER AND LINDA L. SCHLUETER, being of the age of eighteen (18) years or more, do hereby form a business corporation under the laws of the State of Idaho, and do hereby adopt in duplicate the following Articles of Incorporation:

#### ARTICLE I.

#### Corporate Name

The name of this Corporation shall be JET FIGHTERS, INC.

#### MRTICLE II.

#### Corporate Duration

The period of duration of this Corporation shall be perpetual.

#### ARTICLE III.

#### Corporate Purpose

This Corporation is organized for the following purposes:

- A. To acquire aircraft by rental, purchase or other means for the purpose of deriving income from individuals and/or organizations that desire to ride in such aircraft for a fee, to rent such aircraft for a fee, or any other related use of such aircraft.
- B. To transact any other lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

#### ARTICLE IV.

#### Stock

Authorized Shares. The aggregate number of shares of stock authorized and which may be issued by this Corporation are

100,000 shares of common stock of the par value of ONE DOLLAR (\$1.00) per share; all said shares shall be issued fully paid and shall not be subject to assessment.

#### Indemnification

The Corporation shall indemnify to the fullest extent permitted by I.C. § 30-1-5 (and any statutory provisions hereafter enacted to modify, supplement, or replace I.C. § 30-1-5) any person who is made, or threathened to be made, a party to action. suit or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit, or proceeding by or in the right of the Corporation) by reason of any one or more of the following facts:

- The person is or was a director or officer of the corporation or a fiducaiary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to any employee benefit plan of the Corporation.
- The person serves or served at the request of the Corporation as a director or officer, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint wenture, trust, or other enterprise.

The amount of indemnification shall be determined in accordance with the provisions of the Idaho Business Corporation Act in effect at the time of the determination.
