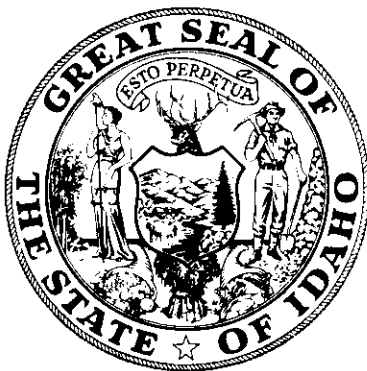

ARTICLES OF AMENDMENT

OF

MEDA-HERB, INC.

MEDA-HERB, INC., an Idaho corporation, being desirous of changing its registered name in the State of Idaho, does hereby make and execute these Articles of Amendment to its Articles of Incorporation as follows:

I.

That the registered name of MEDA-HERB, INC., as prescribed by Idaho Code Section 30-107 be changed to INTERNATIONAL BREAD FIX'INS, INC., P. O. Box 9205, Meridian, Idaho 83707.

II.

The first paragraph of the original Articles of Incorporation of this corporation shall be and hereby is amended to read and provide as follows:

FIRST

The name of the corporation is INTERNATIONAL BREAD FIX'INS., INC.

III.

This amendment was adopted by all of the shareholders of the corporation consenting thereto in writing and by a resolution of the Board of Directors authorizing such amendment at a meeting duly and regularly called for that purpose at which all of the directors of the corporation were personally present and voted for such resolution.
