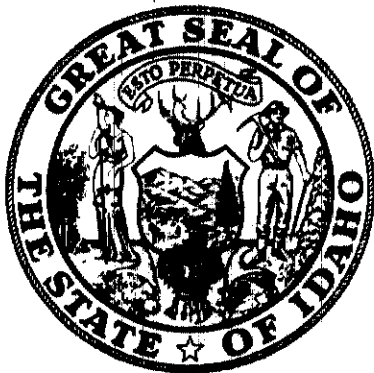

ARTICLES OF INCORPORATION

The undersigned acting as incorporators of a corporation under the Non-Profit Corporation Act adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is THE CHURCH OF CHRIST IN KAMIAH, ID., INC. The corporation shall commence business with the filing of these Articles of Incorporation with the Secretary of State.

SECOND: The period of existence and duration of the life of this corporation is perpetual.

THIRD: The purpose for which this corporation is organized is charitable and non-profit, and the purposes to be carried on are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to:

(a) To establish and maintain a church building and place of worship in Kamiah, Idaho; and thus function as a church in providing religious instruction, admonition, exhortation, and encouragement in an independent and collective manner in accordance with the New Testament and to generally operate as a church with regard to those goals.

(b) The corporation shall have the authority to own real estate, or interests in real estate, for carrying out the corporate purposes of being a church, and it shall have the authority to deal with such real estate as all other corporations might do or could do in the State of Idaho.

(c) The corporation shall have the authority to do any act not inconsistent with the laws of the State of Idaho relating to general business corporations as amended by the Non-Profit Business Corporation Act of the State of Idaho.

FOURTH: The address of the initial registered office of the corporation is 308 Hill Street, Kamiah, Idaho 83536, and the name of its initial registered agent at that address shall be Mark N. Whittak.

FIFTH: The affairs of this corporation shall be managed by a Board of Directors. The qualifications of the Directors, together with the terms of office, manner of election, removal, and filling of vacancies of the newly created directorships, powers, duties and liabilities, except as provided in the By-Laws, shall be prescribed in the By-Laws. The number of directors shall be three people.

SIXTH: The provisions for the membership of the corporation shall be governed by the By-Laws, and the members shall be subject to such regulations and requirements as may be set by the By-Laws.

SEVENTH: By-Laws of the corporation shall be adopted by the directors, and be amended only as provided therein, provided such By-Laws and amendments thereto shall not conflict with these Articles of Incorporation, or the laws of any governmental entity.

EIGHTH: The business of the church may be exercised by the general membership in accordance with 30-314(c) Idaho Code unless the By-Laws otherwise grants specific authority to the Board of Directors to accomplish specific things in the corporation.

NINTH: The Articles of Incorporation may be amended by a vote of a majority of the church members in accordance with Idaho Code §30-327.

TENTH: The rights and interests of all members shall be equal, and no member can have or acquire a greater interest in this corporation than any other member. The corporation shall not issue any capital stock. The corporation is organized on a non-stock basis and there shall be members in lieu of stockholders. The Board of Directors may issue Certificates of Membership to members, or the list of members may be kept at the church in a registry exclusively for that purpose.

ELEVENTH: No part of the net earnings of this corporation shall be distributed to, or inure to the benefit, of any member, director, elder, or officer of this corporation, contributor or private individual. In the event of dissolution, winding up, or other liquidation of the assets of this corporation, its assets shall be distributed to non-profit and charitable corporations, or institutions, or a trust fund in Kamiah, as may be designated by the directors to be used for the purposes similar to those of the corporation.
