ARTICLES OF INCORPORATION

Be it known that we, the undersigned, all of whom are of full age SECRETARY OF CAMERIES of the United States of America, and residents of the STATE AND I Idaho, do voluntarily associate ourselves for the purpose of forming a religious corporation under the laws of the State of Idaho, and particularly under Chapter 3 of Title 30 of Idaho Code, and we do hereby make, subscribe and execute the following articles of Incorporation.

ARTICLE I

NAME

The name of this corporation is SILVER SAGE BAPTIST CHURCH, INC.

ARTICLE II

PURPOSE

This is a nonprofit Corporation, established for the purpose of proclaiming the Gospel of Jesus Christ publically and privately, locally and around the world, to give its members and others an opportunity for the worship, Biblical learning, and service; and the transaction of any lawful activity. The duration of this corporation shall be perpetual.

ARTICLE III

BOARD OF TRUSTEES (DIRECTORS)

The operation of the affairs of this Corporation shall be vested in a Board of Trustees to consist of three or more members, to be elected according to the constitution adopted by Silver Sage Baptist Church December 10, 1995. "The church shall elect three or more trustees to serve as legal officers for the church. They shall hold in trust the church property. Upon a specific vote of the church authorizing each action, they shall have the power to buy, sell, mortgage, lease, or transfer any church property. When the signatures of trustees are required, they shall sign legal documents involving the sale, mortgage, purchase, or rental of property, or other legal documents related to church approved matters. Trustees shall serve on a rotational basis, with one new trustee being elected every year."

Three trustees were elected December 10, 1995, they are: Richard L. Ashworth, 5288 S. Cheyenne Ave., Boise, ID 83709; David L. Ashworth, 5530 Roundup, Boise, ID 83709; William Ryal, 9009 Abram Ln., Boise, ID 83704.
