## AMENDMENT TO

### ARTICLES OF INCORPORATION

BOISE TRACTION COMPANY.

The Boise Traction Company, a corporation incorporated under the laws of the State of Idaho, does hereby certify, FIRST.

That it was incorporated under the laws of the State of Idaho on the 7th day of June, 1919, with its principal place of business at Boise, Ada County, Idaho.

#### SECOND.

That on the 28th day of June, 1919, its Articles of Incorporation were duly amended by changing the name of said corporation from Boise Traction Company to Boise Street Car Company.

# THIRD.

That on the 28th day of June, 1919, at a special meeting of the stockholders of said corporation, duly salled for that purpose, and held at the office of the Company at Boise. Ada County, Idaho, at which meeting Stockholders helding more than two-thirds of the entire capital stock of the Company, namely, all of the Stockholders of said Company, and all of its stock, to-wit, three shares, votes in favor of changing the name of said Company from Boise Traction Company to Boise Street Car Company, and votes in favor of changing such name and amending the Articles of the Company accordingly,

and in relation thereto the following resolution was unanimously adopted at said special Stockholders' Meeting:

"BE IT RESOLVED, By the Stockholders of the Boise Traction Company in special meeting for the purpose assembled, that the name of this corporation be changed by striking out the words 'Traction Company' in the present name and inserting in lieu thereof the words 'Street Car Company', and that the name of this corporation hereafter be 'Boise Street Car Company', and

BE IT FURTHER RESOLVED. That subdivision 'FIRST' of the Articles of Incorporation of this Company heretofore filed with the Secretary of State of the State of Idaho, and with the County Recorder of Ada County, Idaho, be amended to read as follows:

#### PIRST

That the name of this corporation is and shall be Boise Street Car Company', and

BE IT FURTHER RESOLVED. That the Chairman and Secretary of this meeting be and they hereby are directed to cause a proper certificate of amendment to the Articles of Incorporation of this Company to be executed and filed in accordance with the Statutes of the State of Idaho in such case made and provided."
