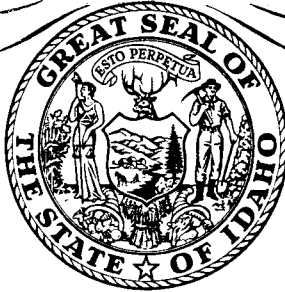

ARTICLES OF INCORPORATION
OF
WEISER AREA UNITED FUND, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

NAME

The name of this corporation shall be the WEISER AREA UNITED FUND, INC.

ARTICLE II

PURPOSE

The purpose or purposes for which it is formed are:

A. To bring together in a united appeal all possible campaigns of community-accepted health, welfare, and recreational agencies, including local, state, and national service organizations.

B. To solicit funds and property for such agencies; to acquire by gift, legacy, devise, purchase, or otherwise, property of every kind and nature, both real and personal, for such agencies; to lease, mortgage, improve, pledge, sell, convey or otherwise dispose of such property.

C. To invest and expend funds, and to distribute funds to such agencies.

D. To create a more general interest in the service of such agencies and in the unified appeal plan.

E. To do all acts and things necessary, convenient, or expedient to carry on the above mentioned purposes.

ARTICLE III

DURATION

The period of existence and period during which it is to continue as a corporation is perpetual.

ARTICLE IV

ARTICLE V

STOCK

This corporation is organized on a non-stock basis and all proceeds shall be used solely for charitable purposes.

ARTICLE VI

Directors

The affairs of this corporation shall be directed by a Board of Directors consisting of no fewer than nine (9) nor more than twenty-four (24) persons, the exact number, within such limitations, to be determined at the annual meeting of the corporation and they shall be elected to serve for a period of three years. At all times the number of members of the Board of Directors shall be divisible by 3.
