#### ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of eighteen years or more, acting as incorporators of a corporation (herein called "Corporation") under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

#### ARTICLE ONE

The period of its duration is perpetual.

The purpose or purposes for which the corporation is organized are:

#### ARTICLE ONE

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on June 14, 1982.
