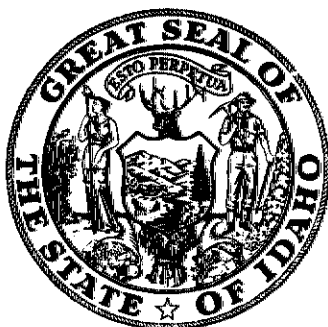



STATE OF IDAHO OF

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME; The name of the corporation is The Miley Agency, Inc.
- D 2. DURATION. The period of its duration is perpetual.
3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. In addition, the corporation shall be involved in the transaction of business for which it shall be licensed as a resident agent or resident broker in relation to all kinds of insurance, all as provided for in Idaho Code S41-1036(4).
4. STOCK. The corporation shall have the authority to issue 10,000 shares of capital stock, all of one (1) class, ONE DOLLAR (\$1.00) par value.
