The undersigned, acting as sole incorporator of a domestic corporation under and subject to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation for the corporation ("these articles"):

First Article

The name of the corporation is

TUMBLEWEED FABRIC AND DESIGNS Incorporated.

Second Article

The period of the corporation's duration is perpetual.

Third Article

The purpose or purposes for which the corporation is organized are the ownership and operation of a fabric and design sales and service facility and any other lawful purpose or purposes.

Fourth Article

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of common stock in a single class and having no par value.

Fifth Article

No provisions of these articles deny any preemptive rights with respect to any shares authorized by these articles.


