To the Secretary of State of the State of Idaho,

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit religious corporation amends and restates its articles of incorporation as follows:

1. The Name of the Corporation is Bethel Baptist Church, Inc.
2. The text of the restated articles is as follows:

### Article 1: Name

The name of the corporation is *Bethel Baptist Church, Inc.*

### Article 2: Purpose.

The purpose for which the corporation is organized is *Knowing God and Making Him known by:*

1. Promoting the doctrines and teachings of Christ Jesus as understood by Bethel Baptist Church,
2. Providing education and training,
3. Owning and maintaining suitable real estate and buildings,
4. Providing for its members a place of worship, education and training,
5. Receiving, holding and disbursing gifts, bequests, devises, and other funds,
6. Doing all things supporting, or necessary and incident thereto.
