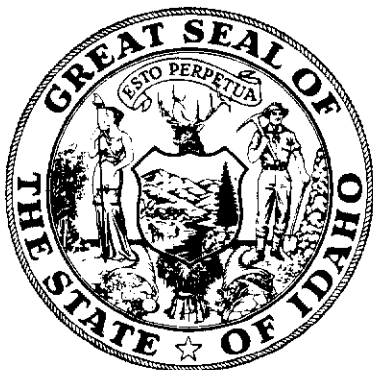

ARTICLES OF INCORPORATION
OF
CHUBBUCK UNITED METHODIST CHURCH, INC.
A Nonprofit Corporation

The undersigned, acting as incorporators of a corporation under the IDAHO NONPROFIT CORPORATION ACT, adopt the following ARTICLES OF INCORPORATION for such corporation:

FIRST: The name of this nonprofit corporation is Chubbuck United Methodist Church, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is for the organization of a church and for any and all religious activities associated therewith, as well as the transaction of any and all lawful business for which such a nonprofit corporation may be incorporated under the Idaho Nonprofit Corporation Act.

FOURTH: This nonprofit corporation shall have and exercise all the powers of nonprofit corporations in addition to those powers granted to corporations generally, unless otherwise specifically limited by the Book of Discipline of the United Methodist Church, as the same now exists or may hereafter be amended.

1. ARTICLES OF INCORPORATION OF

FIFTH: This nonprofit corporation shall have no capital stock and shall be composed of members rather than shareholders.

SIXTH: The management of the affairs of this nonprofit corporation shall be vested in its members through duly elected officers known as a Board of Trustees which shall be composed of no less than three (3) nor more than nine (9) members, who shall be elected for terms of three (3) years or until their successors are elected and qualified, or for such term as may be provided for in the Book of Discipline of the United Methodist Church as the same now exists or may hereafter be amended.






