

I.

The name of this corporation is **Pocatello Orthopaedics & Sports Medicine Institute, P.A.**

II.

The period of duration for this corporation shall be perpetual.

III.

This corporation is organized as a professional corporation pursuant to Idaho Code § 30-1301, et. seq. for the purpose of rendering orthopaedic services by physicians who are licensed to practice medicine under the laws of the State of Idaho. This corporation may not engage in any other business; however, the corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may also own real or personal property necessary for the rendering of professional services.

IV.

The corporation shall have authority to issue 10,000 shares of stock with no par value. All shares shall be of the same class and value and have the same voting and other rights. All of the stock issued shall be fully paid and nonassessable. None of the

shares of this corporation may be issued to anyone other than an individual licensed to practice medicine in the State of Idaho.

V.

The name of the registered agent for the corporation is Hugh Selznick, M.D. and the address of the registered office is Hugh Selznick, 333 n. 18th, Suite D-1 Pocatello, ID 83201.

VI.


