### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**IDAHO FALLS RESTAURANT AND BAR ASSOCIATION, INC.**

was filed in the office of the Secretary of State on the **Twenty-second** day of **November** A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Idaho Falls** in the County of **Bonneville,** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF  
IDAHO FALLS RESTAURANT AND BAR ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full legal age, residents of the State of Idaho, and citizens of the United States of America, for the purpose of forming a non-profit co-operative association under and by virtue of the laws of the State of Idaho, relating to private corporations, have this day voluntarily associated ourselves together, and hereby agree as follows:

I.

The name of this association shall be and is Idaho Falls Restaurant and Bar Association, Inc.

II.

This corporation shall have perpetual existence, unless the same is sooner dissolved or disincorporated pursuant to law.

III.

This corporation is organized at and the place of its principal office and place of business shall be Idaho Falls, Bonneville County, State of Idaho.

IV.

The association shall not engage in any business, trade, avocation or profession for gain or profit.

V.

The association shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificates shall not be assignable so that the transferee can, by such transfer alone, become a member of this association. Each such transferee shall become a member of the association only by resolution of the Board of Directors, and under such regulation as the by-laws may prescribe. The rights and interests of all members shall be equal and no member can acquire a greater interest than another member.

## VII.

The purposes and objects of this corporation are and shall be to promote and advance the general well-being and profit of the members of the association; the association shall have the right to affiliate with any national or state organization having common or similar objectives.

## VIII.

Any person operating an eating establishment of any kind or description or any licensee of the State of Idaho for the sale of beer or liquor shall be eligible for membership upon such terms and conditions as the by-laws shall prescribe.

## IX.

The association shall have the right and authority to enter into contracts or obligations of any type or kind essential, necessary or proper in the transaction of the ordinary affairs of the association, or for the welfare of the association.

## X.

The private property of the members of this association shall not be liable for the debts of the association.

## XI.

The power to repeal and amend the by-laws and to adopt new

by-laws is hereby conferred upon the Board of Directors.


