ARTICLES OF INCORPORATION

Of

WHITE & WHITE OPPIOR MINING COMPANY

ANOW ALL MEN BY THESE PRESENTS that we, the undersigned citizens of the United States of America, hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby adopt the following articles of:

Article 1.

The name of this corporation shall be White & White Option Lining Company.

Article 11.

The purposes for which it is formed are to acquire, hold, work, operate, buy and sell mines and mining property, and to acquire, own, use, buy and sell water, water rights and mills incident to the extraction, treatment and production of ores; to sell and convey such mines, miles and water rights and ores and to do all things incident to the general business of mining and to treat and market the product of mines; also to purchase, lease, erect and operate smelting and refining works and also to buy and sell ores and metals and to do all things incident to the general business of concentrating, smelting and refining ores and metals and the sale and disposal of the products thereof.

Article 111.

The place where the principal business of said corporation is to be transacted is Osborne, Shoshone County, Idaho.

Article 14.

The term for which said corporation is to exist shall be fifty years from the date of the execution of these articles.

Article V.

The number of directors shall be five.

The amount of capital stock of said corporation shall be SEVERTERS THOUSAND FIVE HUNDRED DOLLARS (\$17.500.00) divided into 1.750,000 chares of the par value of CER CERT each.
