**ARTICLES OF AMENDMENT**

**Amending the Name of Maskal Forages, Inc.**  
**to The Teff Company**

We, the undersigned, pursuant to the Idaho Business Corporation Act, desiring to effect a change of corporate name, adopt the following Articles of Amendment to the Articles of Incorporation of Maskal Forages, Inc.:

**ARTICLE ONE**

The following amendment to the Articles of Incorporation was adopted by the stockholders of the corporation on the 26th day of October, 1992:

**ARTICLE THREE**
