

Articles of Incorporation of Hanson Trucking, Inc.



The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

NAME: The name of the Corporation is Hanson Trucking, Inc.
