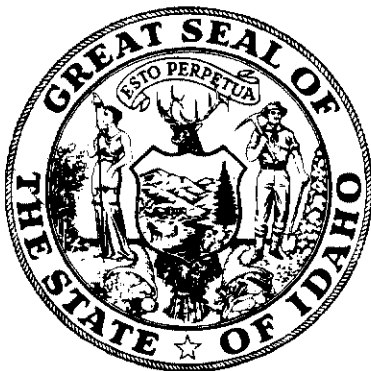

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Buy Idaho, Incorporated.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the membership and directors of the corporation by written action and consent dated AUGUST 2, 1989, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, That Article I of the Articles of Incorporation of Buy in Idaho, an Idaho corporation, be amended to read as follows:

The name of the Corporation is Buy Idaho, Incorporated, hereinafter called the "Corporation."

BE IT FURTHER RESOLVED, That the President and the Secretary of the corporation prepare and file with the Office of the Secretary of State of the State of Idaho Articles of Amendment reflecting the foregoing amendment to the Articles of Incorporation.

THIRD: The number of ~~members~~ <sup>voting</sup> of the corporation at the time of such adoption was 15, and the number of ~~voting members~~ entitled to vote was 15 shares.

FOURTH: The number of ~~members~~ <sup>voting</sup> who voted in favor of such Amendment was 10 shares, and there were no votes against such Amendment.
