## ARTICLES OF INCORPORATION - NONPROFIT CORPORATION

We, the undersigned, residents of the State of Idaho, being of legal age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

### ARTICLE ONE NAME

The name of the corporation shall be HERITAGE CENTER FOR LEARNING, INC..

### ARTICLE TWO TYPE OF CORPORATION

This corporation is a nonprofit corporation and shall have no distributable income.

### ARTICLE THREE DURATION

The duration of this corporation shall be perpetual.

### ARTICLE FOUR PURPOSE

This corporation is organized for the following purpose: to establish and operate an educational facility which will provide instruction, learning experiences, and developmental opportunities for the levels of preschool, kindergarten, and elementary through high school. The corporation shall have the right to do and accomplish all things and engage in any lawful activity which may befit its purpose and designation as a nonprofit corporation within the laws of the State of Idaho.

### ARTICLE FIVE MEMBERSHIP

Rules governing membership, and the rights and qualifications of members shall be stipulated in the bylaws of this corporation.

### ARTICLE SIX INTERNAL AFFAIRS

Management of this corporation shall support and be guided by its bylaws.

### ARTICLE SEVEN ADDRESS
