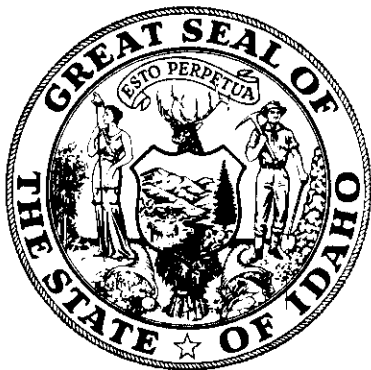

ARTICLES OF AMENDMENT  
OF

DEE DEE ENTERPRISES, INC.

Pursuant to Idaho Code Section 30-1-61, DEE DEE ENTERPRISES, INC. adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the Corporation is DEE DEE ENTERPRISES, INC.

ARTICLE II

The following amendment of the Articles of Incorporation was adopted by the Board of Directors on August 6th, 1980, before any shares were issued, in the manner prescribed by the laws of the State of Idaho and the Articles of Incorporation:

The total authorized number of shares of the Corporation shall consist of Three Hundred (300) shares of Common Stock having a par value of One Hundred (\$100) Dollars per share for a total value in stock of Thirty Thousand (\$30,000) Dollars, all of one (1) class denoted Common Stock, each share being entitled to one (1) vote.

ARTICLE III

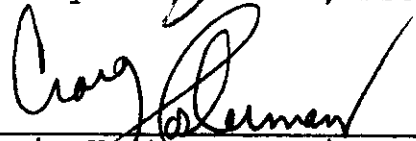
The number of shares of the Corporation outstanding at the time of such adoption was none, no shares having yet been issued at the time of adoption of the Amendment by the Board of Directors.

ARTICLE IV

The proposed Amendment will effect a change in the amount of stated capital in the Corporation by increasing the total value in stock of the Corporation from Ten Thousand (\$10,000) Dollars to Thirty Thousand (\$30,000) Dollars, which will be the new stated capital of the Corporation pursuant to said Amendment.
