## ARTICLES OF AMENDMENT 8 PM 4 18 TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SEC. TARY OF

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation.
