The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Idaho, adopts the following Articles of Incorporation:

Article 1. The name of the corporation is Teton View Enterprises Incorporated.

Article 2. The purpose for which this corporation is organized is to transact any and all lawful business for which corporations may be organized under the laws of the State of Idaho, and to have all powers that are afforded to corporations under the laws of the State of Idaho.
