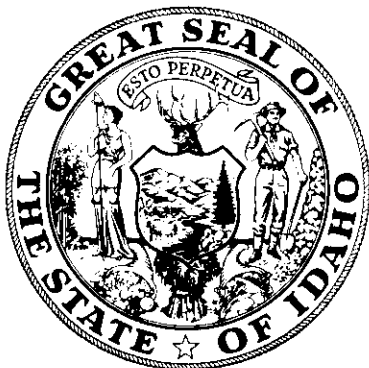

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is VITRONICS, INC.

II.

The corporation is to have perpetual existence.

III.

The corporation is organized for the purpose of merchandising, installation and servicing of electronic recreation equipment and paraphernalia, and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The authorized capital of the corporation consists of a single class of stock, the total number of authorized shares is \$25,000 with a par value of \$1.00 and an aggregate par value of \$25,000.00.

V.

The address of the initial registered office of the corporation is 2465 Overland Road, Boise, Idaho 83705.

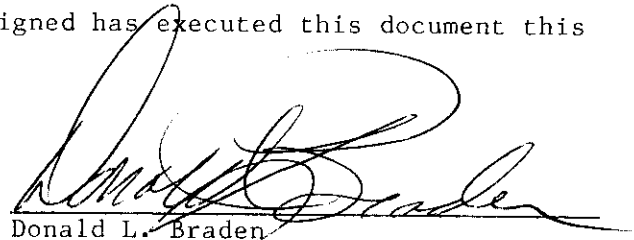

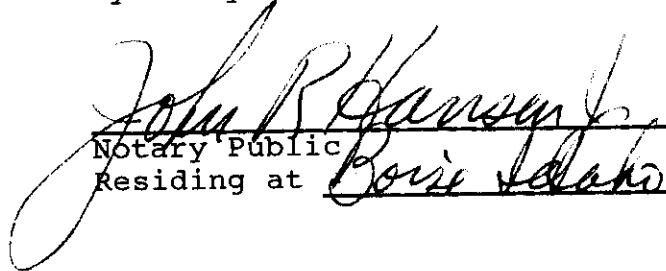
