The undersigned, acting as incorporator of a Corporation under the Idaho Business Corporation Act and in order to form a Corporation under the provisions of Title 30, Chapter 1, Idaho Code, submits the following Articles of Incorporation:

**Article 1:** The name of the corporation shall be: **BG ELECTRIC, INC.**

**Article 2:** The period of its duration is perpetual.

**Article 3:** The purpose for which the corporation is organized is to engage in and carry on a general electrical work installation business primarily for residential and commercial installations, remodeling and service work and to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporation Act.

**Article 4:** The number of shares the corporation is authorized to issue is 1000, all of one class, having no par value.
