THIS CERTIFICATE OF AMENDMENT to the Certificate of Limited Partnership is prepared and recorded pursuant to the requirements of the Idaho Limited Partnership Act to reflect the amendments to the Limited Partnership Agreement.

1. Name. The name of the partnership continues to be Mountain Vista Associates, an Idaho Limited Partnership.

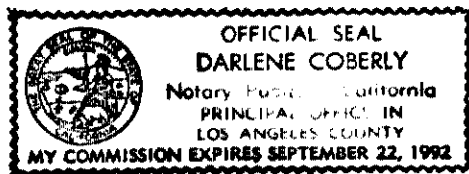

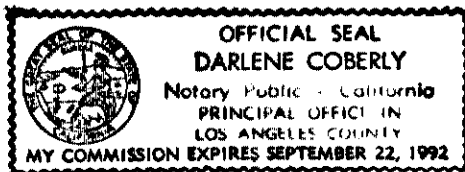
