
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

DICK'S MOBILE HOME SERVICE, INC.

FIRST: The name of the corporation is: DICK'S MOBILE HOME SERVICE, INC.

SECOND: The address and name of the registered agent of the corporation in the State of Idaho are: Irvin Kirkpatrick, 1530 Fairmont Loop, Coeur d'Alene, Idaho 83814.

THIRD: The purpose of the corporation is to engage in the service and transportation of mobile homes and any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act.

FOURTH: The duration of the corporation shall be perpetual.

FIFTH: The corporation shall be authorized to issue two classes of common stock in the total amount of 150,000 shares, divided into 15 percent voting stock and 85 percent non-voting stock. Each of said shares shall be sold and issued for \$1.00 per share in cash or other property for a period of not more than two years of the date hereof. The corporation shall qualify the stock offered and issued under this plan as "Section 1244 stock," as such term is defined by Section 1244 of the Internal Revenue Code.

SIXTH: All of the stock of the corporation shall be restricted as to transfer as provided by the By-Laws of the corporation.
