ARTICLES OF INCORPORATION
OF
WEISER GIRL SCOUTS, INC.
(A NONPROFIT CORPORATION)

1. The name of the corporation shall be WEISER GIRL SCOUTS, INC.

2. This is a nonprofit corporation, which means a corporation no part of the income of which is distributable to its members, directors, or officers.

3. The period of duration shall be perpetual.

4. The purposes for which the corporation is organized are:

a. to be the successor to WEISER GIRL SCOUTS, INC., a nonprofit cooperative association, that was originally incorporated February 11, 1946, under the laws of the State of Idaho, and to carry out all the same purposes of WEISER GIRL SCOUTS, INC., a nonprofit cooperative association, as set forth in its Articles of Incorporation.

b. to provide a building for the use of girl scouts and other scout groups to carry on their educational, recreational, and character building activities.

c. to engage in fund raising, to lease and/or hold title to real and personal property, and to engage in any and all lawful activities that may be incident to or reasonably necessary for any of the above purposes. This corporation is organized for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation

exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or its successor provision), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) Internal Revenue Code (or its successor provision).

5. The corporation shall have members and advisory members. Advisory Membership shall be open to any person or entity interested in the purposes of the corporation, including any individual (regardless of age, race, sex, religion, nationality, language, or disability), and to any group, organization or business firm. The Board of Directors may establish and fix from time to time the amount of any dues to be paid or donated by volunteer service by members or advisory members.

6. The management of its affairs shall be vested in the Board of Directors, who shall be elected by the corporation's members, as provided in the By-laws.

7. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the State or to a local government for a public purpose.
