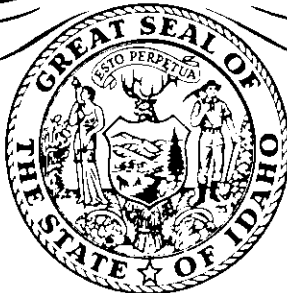

ARTICLES OF INCORPORATION

FIRST:

The Title of this Corporation will be Hamco Real Estate & Investments, Inc.

SECOND:

The principal place of business will be Route #4, Buhl, Idaho 83316.
The Manager in charge will be J.P. Hamilton, Route #4, Buhl, Idaho 83316.

THIRD:

The objects for which this corporation is formed shall be:

1. To buy, sell, lease, rent or trade real property.
2. To purchase or acquire by other means real or personal property and to lease, rent, sell or dispose of such property.
3. To acquire by purchase or otherwise stocks, bonds, loans, contracts, leases of corporations or individuals and to exercise all rights, privileges, and functions incident with the ownership of such.

FOURTH:

The total authorized capital stock of this corporation will be Fifty Thousand Dollars (\$50,000.00) divided into five thousand (5000) shares at \$10.00 par value per share.
