ARTICLES OF INCORPORATION

OF

IDAHO ADVENTURES STEELHEAD, INC.

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, I.C., Section 30-1-1 et seq, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is IDAHO ADVENTURES STEELHEAD, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: Floating, river, outfitting and guiding business and or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as now written or may hereafter be amended,

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares, without par value.
