

The undersigned incorporator, in order to form a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation:

Article 1

The name of this corporation is YOUTH AND YOUNG ADULT MINISTRIES CONSULTANTS, INC.

Article 2

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Idaho Nonprofit Corporation Act for religious purposes.

Article 3

The specific and primary purpose of this corporation is to empower families, communities, churches and para-church organizations for ministry in the twenty-first century through religious and educational youth and young adult events, youth and young adult leaders seminars that increase the level of competency of ministry to this age group, parenting seminars, consultations and the development, production and distribution of written materials that enhance the aforementioned activities. Empowering families, communities, churches and para-church organizations for ministry in the twenty-first century includes involvement with persons of all ages, organization and activities that promote spiritual development and the quality of life within the United States and throughout the world. Additionally, the corporation will engage in any other lawful act or activity for which it was organized under the Idaho Nonprofit Corporation Act.

Article 6

The corporation shall have no members.

Article 7

- (a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from Federal income tax under Section (c) (3) of the Internal Revenue Code, or (2) by a corporation to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
- (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Article 8

The property of this corporation is dedicated to religious, educational and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any private persons. Upon the dissolution of the corporation, it's assets remaining after payment of all debts and liabilities of this corporation shall be distributed as determined by the board of directors to a nonprofit fund, foundation or corporation organized and operated exclusively for religious, educational and charitable purposes and which has established it's tax exempt status under Section 501 (c) (3) of the Internal Revenue Code. Examples of such organizations include the Youth Resource Center at Andrews University in Berrien Springs, Michigan; the John Hancock Center for Youth Ministry at La Sierra University in Riverside, California; and Piece of the Pie Ministries, Inc. in Carmichael, California; and the Idaho Conference of Seventh-day Adventists Senior Youth Department in Boise, Idaho. Each of these named entities has established it's tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.
