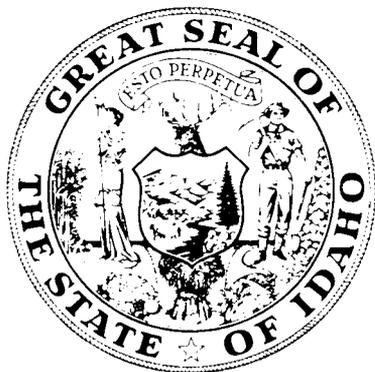

IDAHO BUSINESS CORPORATION ACT

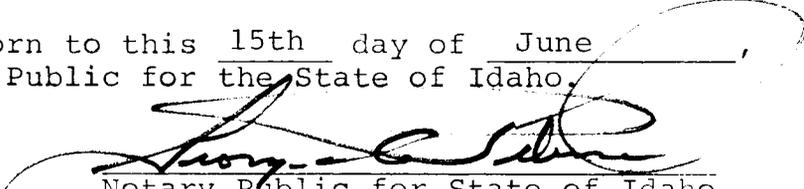
