#### ARTICLES OF INCORPORATION

FAITH COMMUNITY CHURCH, INC. BOISE, IDAHO

At a special called meeting of all interested parties at the Maple Grove Grange Hall on Maple Grove Road, Boise, Idaho at the hour of 7:30 on July 15, a motion was made, seconded and passed that the undersigned trustees be authorized and directed to execute and file Articles of Incorporation, incorporating the group assembled as Faith Community Church of Boise, Idaho a non profit corporation, under the laws of the State of Idaho, Title 30, Chapter 11, of the Idaho Code.

Now therefore, we the undersigned:

Trustees, are over the age of 21 and citizens of the United States and of the State of Idaho, being the designated and authorized persons, do hereby execute and acknowledge these Articles of Incorporation of the Faith Community Church of Boise, Idaho as follows:

#### ARTICLE I - NAME

The name of this organization, a corporation shall be FAITH COMMUNITY CHURCH OF BOISE, IDAHO, INC.

#### ARTICLE II - PURPOSE

The purpose of this Church shall be:

- 1. To always endeavor to see that the Gospel of the Lord Jesus Christ is preached and taught in the community.
- 2. To see that the Bible is taught to those who attend the Church services. To that end, a Sunday School, non-denominational in character and conduct, shall always be carried on by the Church.

- 3. To assist in every possible manner to promote the spiritual, moral and social life of the community.
- 4. It is declared that the preaching of the Gospel and the teaching of the Bible in every department of the Church shall be non-denominational in its scope and character and without any prejudice toward any faith or creed that is fundamental in its belief and teaching, and that all teaching shall always be loyal to the Government of the United States, so long as it is in accord with the teaching of Christian life, liberty, and the pursuit of happiness in our State and National Constitutions.

#### ARTICLE III - MEMBERSHIP

The membership of this church shall consist of believers in the Lord

Jesus Christ who have been baptised; and acknowledge substantial agreement with the faith and practices of this church, its covenants and bylaws; and have been received into its fellowship by regular action of the
church.

#### ARTICLE IV - OFFICERS

The officers of this Church are five Deacons, five Trustees, three Deaconesses, the Church Clerk, the Church Treasurer, the Sunday School Superintendent, the Choir Director and the President of the Ladies Auxiliary. The Trustees shall be elected for a term of three years by the active membership at the Annual Business Meeting held in May of each year. Only active members as set forth in the Constitution shall have the right to vote.

## ARTICLE V - STATEMENT OF FAITH

- 1. THE SCRIPTURES: We believe the Bible is the inspired Word of God.
  II Timothy 3:16,17
- 2. GOD: We believe there is one God eternally existent in three Persons:
  The Father, The Son, and The Holy Spirit. Matthew 28:19

- 3. THE DIETY OF JESUS CHRIST: We believe in the Deity of Christ, His virgin birth; His shed blood for atonement; His bodily resurrection; His personal premillenial return. I John 5:20
- 4. THE FALL OF MAN: We believe that all men are by nature sinful and lost and that for salvation, Holy Spirit regeneration is absolutely essential. Romans 5:12 and Romans 3:9,10
- 5. REDEMPTION FROM SIN: We believe that men are justified on the single ground of faith in the shed blood of Jesus Christ. Romans 5:6-11
- 6. SALVATION BY GRACE: We believe that faith in the finished work of the Lord Jesus Christ is the only condition of salvation from sin and this salvation is wholly by grace. Ephesians 2:8,9
- 7. THE CHURCH: We believe that a New Testament Church is an organized body of baptized believers practicing Scriptural ordinances and actively engaged in fulfilling the Great Commission. Matthew 16:16-18, Mark 16:15-18 Ephesians 1:22,23
- 8. THE ORDINANCES: We believe that there are two church ordinances:
  Baptism and the Lord's Supper. That Baptism is a Scriptural ordinance
  required of the believers. Matthew 28:19, Mark 1:9-11

We believe the Lord's Supper is a Scriptural ordinance of the church that is partaken of by fellow Christians in commemoration of the death of the Lord Jesus Christ. 1 Corinthians 11:23-28

9. THE RESURRECTION: We believe in the resurrection of both the saved and the lost; the saved unto the resurrection of life, and the lost unto the resurrection of damnation. John 5:28,29

# ARTICLE VI - POWERS OF CORPORATION

The Trustees shall have no power to buy, sell, mortgage, lease or otherwise transfer or encumber property of the Church without first receiving authority from the congregation of the Church to do so, after a meeting of the congregation, which has been duly publicized two Sundays previous, for such purpose according to the duly enacted by-laws of this corporation and a two-thirds (2/3) majority vote of those members present having voted in the affirmative to so instrust the Trustees. Nor shall the Trustees have exclusive control over the use of the Church and the church property until said Trustees have been instructed by a majority vote of the members of the congregation as aforesaid.

The powers of this Corporation shall include, but not be limited to the following:

- To purchase, own and convey property.
- 2. To mortgage and to loan money.
- 3. To purchase and use all that is necessary for church life and operation in the pursuing of the aforementioned purposes.
- 4. To hire and bond personnel necessary for the accomplishing of the purposes of this Corporation.
- 5. Such other powers permitted or granted by law, which are in keeping with, or in aid of, the general purposes of the Corporation.

#### ARTICLE VII - LOCATION

This Corporation shall be located in Ada County, and the Post Office address shall be Boise, Idaho. The duration of this Corporation shall be perpetual. In the case of dissolution all properties shall be conveyed to a Mission designated by a two-thirds (2/3) vote of the membership.

## ARTICLE VIII - AMENDMENTS

These Articles of Incorporation may be amended by a two-thirds (2/3) vote of a quorum of active members present and voting at any business meeting provided such amendments have been submitted in writing at a previous meeting held not less than one month before the time of voting. A public

notice of the intention to amend the articles of incorporation shall have been given by publication at least once a week for four weeks in the local newspaper.
