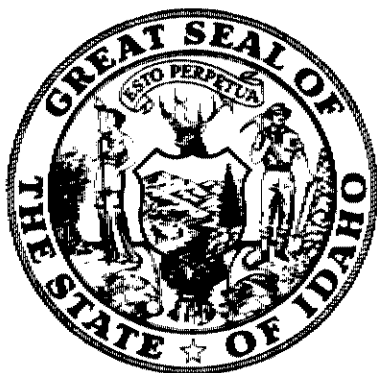

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE

The name of this corporation shall be OUTREACH MISSIONS, INC.

ARTICLE TWO

This corporation shall be a non-profit corporation meaning no part of the receipts or income of the corporation will be distributable to its directors or officers.

ARTICLE THREE

The period of duration of this corporation shall be perpetual.

ARTICLE FOUR

The purpose for which this corporation is organized is to promote the teachings and proclaim the gospel of our Lord Jesus Christ utilizing contributions, donations and gifts to fund various ministries and to provide financial support to various ministries throughout the world.

ARTICLE FIVE

This corporation is organized and is to be maintained for independent mission outreach and shall not be affiliated with or controlled by any convention, conference, association, synod, denomination, organization, or religious order.

ARTICLE SIX

The government and affairs of this corporation shall be managed by a Board of Directors, who shall be elected by the members in good standing. The number of Directors shall be fixed by the Bylaws, however, there shall at all times be at least three (3) Directors. The term of Directors shall be three (3) years and the Directors shall be divided into three classes, each class to be as nearly equal in number as possible. The term of office of Directors of the first class to expire at the first annual meeting of the members after first election of Directors at the

initial annual meeting of members, that of the second class to expire at the second annual meeting after their election, and that of the third class to expire at the third annual meeting after their election. At each annual meeting after first election of Directors at the initial annual meeting of the number of Directors equal to the number in the class whose term expires at the time of such meeting shall be elected to hold office until the third succeeding annual meeting.

ARTICLE SEVEN
