ARTICLES OF INCORPORATION
OF

PIONEER TITLE COMPANY OF BANNOCK COUNTY, INC.

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of this corporation is PIONEER TITLE COMPANY OF BANNOCK COUNTY, INC., organized and existing under and by virtue of the laws of the State of Idaho.

SECOND: The following amendment of the Articles of Incorporation of this corporation was adopted by all of the stockholders of the corporation on the 28 day of February, 1991, in the manner prescribed by the Idaho Business Corporation Act:

"ARTICLE III

The capital stock of this corporation shall be \$200,000.00 divided into 200,000 shares with a par value of \$1.00 per share. All of the stock shall be non-assessable common stock with equal voting and other rights and privileges. The shares shall not be divided into classes."


THIRD: The number of shares of the corporation outstanding at the time of such adoption was 89,500. All of the stockholders of the corporation executed an agreement in lieu of a meeting and adopted the above amendment on the 28 day of February, 1991. The Board of Directors also adopted the described amendment by an agreement in lieu of a special meeting of the Board of Directors on the 28 day of February, 1991. The Board of Directors authorized the President and Secretary to cause Articles of Amendment to be prepared, sworn to and filed as required by law to accomplish the amendment of the Articles of Incorporation in accordance with the agreement in lieu of a special meeting of the stockholders.

FOURTH: The manner in which such amendment effects a change in the amount of stated capital and the amount of stated capital as changed by such amendment is that the authorized capital

stock of the corporation is increased from \$100,000.00 divided into 100,000 shares with a par value of \$1.00 per share to the sum of \$200,000.00 divided into 200,000 shares with a par value of \$1.00 per share.




