RESOLVED, that the Certificate of Incorporation of ARCO ENVIRONMENTAL COMPANY, INC. be amended by changing the Article 1. thereof so that, as amended, said Article shall be and read as follows:

SECOND: That in lieu of a meeting and vote of stockholders, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of section 228 of The General Corporation Law of the State of Delaware.

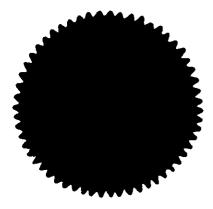
