AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for Perpetual Existence from the date hereof, with its registered office in this State located at Boise, Idaho in the County of Ada and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service

and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

0F

CHRISTIAN SCIENCE SOCIETY, BOISE, IDAHO,

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age, citizens of the United States of America, and residents of the State of Idaho, have this day voluntarily associated ourselves together and do hereby and by these Articles of Incorporation unite and associate ourselves together for the purpose of forming a religious corporation under Chapter 11 of Title 30 of the Idaho Code, for the purposes hereinafter stated:

I.

The name of this corporation shall be: CHRISTIAN SCIENCE SOCIETY, BOISE, IDAHO.

II.

The duration of this corporation shall be perpetual.

III.

The location and post office address of the registered office of this corporation in the State of Idaho shall be Boise, Ada County, Idaho.

IV.

The objects and purposes for which this corporation is formed are as follows:

A. To carry on and conduct public services and the religious and benevolent objects of a church, religious worship, teaching and preaching the gospel as interpreted by Christian Science; and to maintain the truth recorded in the Bible as interpreted by Christian Science and as taught in Science and Health with Key to the Scriptures by Mary Baker Eddy, all in accordance with the manual of The Mother Church, The First Church of Christ, Scientist, Boston, Massachusetts;

To establish and maintain a place or places of worship and teaching for the meetings of the church and to buy, sell, own, build, lease, acquire and use a church building or buildings and to furnish and maintain the same, to teach and practice Christian Science and metaphysical healing, and to do all things incident and pertinent to such purposes, or usual in such church or society; To receive gifts, legacies, and donations from any source whatsoever and to expend the same in carrying out the objects of the corporation; To exercise all such power and authority as may be necessary to carry out the purposes and objects above specified, but the purpose and essence of this corporation being purely religious, it is expressly declared that this is a corporation not for gain or individual profit and that no dividend shall ever be declared or paid to any of the members and that none of its property, real or personal, shall ever be used or expended except in carrying into effect the legitimate aims and ends of its being;

- E. To purchase, receive, lease as lessee, or in any other manner acquire, own, hold, maintain, use, convey, sell, lease as lessor, exchange, mortgage, pledge or otherwise dispose of any and all real and personal property or any interest therein, franchises, licenses, copyrights and rights useful or appropriate to enable the corporation to accomplish any or all of its purposes;
- F. To borrow money and execute notes or other evidence of indebtedness to secure monies borrowed or in payment for property acquired or for any of the other objects or purposes of the corporation, and to secure the payment of such notes or other evidence of indebtedness by mortgage, deed of trust, pledge or other lien upon any or all of the property, rights, privileges or permits of the corporation;

G. To do and perform, either for itself or its members, any and all acts and things and to have and exercise any and all powers as may be necessary or convenient to accomplish any or all of the foregoing purposes and any other business calculated, directly or indirectly, to promote the interests of this corporation, and to have and to exercise all of the powers conferred by the laws of the State of Idaho upon corporations formed under the act pursuant to and under which this corporation is formed;

H. It is the intention of the incorporators of this corporation that the foregoing clauses shall be construed both as objects and powers and the foregoing enumeration of specific objects and powers shall not be construed to limit or restrict in any manner the powers of the corporation, but said corporation shall have the power to do all and everything necessary, suitable, convenient or proper for the accomplishment of any of its purposes, or the attainment of any one or more of the objects hereinabove enumerated, or incidental to the purposes and objects hereinabove named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation, and which is permitted under the laws of the State of Idaho, under which this corporation is organized, to the same extent and as fully as natural person might or could do.

٧.

This corporation is formed without any purpose of pecuniary profit to itself and shall have no capital stock, but it shall issue membership certificates to each member thereof as provided by law.

VI.

The number and qualification of members and the terms and conditions of admission, the time, mode, conditions and effect of expulsion or withdrawal from, and of restoration of membership, the assignment or transfer of the interest of members, the manner of determining the value, if any, of such interest, and the purchase by the corporation, at its option, of such interest upon the death,

withdrawal or expulsion of a member, fees for admission, assessments or dues, time of payment and manner of collecting amounts due and for forfeiture of the interest of a member for nonpayment, contracting, securing, paying and limiting the indebtedness of the corporation and other regulations not repugnant to the laws of the State of Idaho and consonant with the objects of the corporation shall be provided for in the By-Laws of this corporation.

VII.

The private property of the members of the corporation shall be exempt from execution for the debts of the corporation and no member shall be individually liable or responsible for any debts or liabilities of the corporation.

VIII.

The business of this corporation shall be managed and conducted by a board of five (5) directors and such other officials to be elected by the members for the terms and on the conditions prescribed by the By-Laws of the corporation.

IX.

The undersigned, Louise Holland, of 5000 Mountain View Drive, Boise, Idaho, hereby certifies and verifies that she was the presiding officer of a meeting of the members of Christian Science Society, Boise, Idaho, held at Cluster F, Valley View School, 3555 Milwaukee Street, Boise, Idaho, at 9 p.m. on Wednesday, August 15, 1973, for the purpose of electing five (5) Directors of Christian Science Society, Boise, Idaho; that public notice of the time and place of holding such meeting and election was given by publication in the Idaho Statesman, a newpaper published in Boise, Ada County, Idaho, in which said election was held, once a week for two weeks, to-wit, in the issues of August 6, 1973, and August 13, 1973, and by the undersigned posting a like notice in a conspicuous place on the building where such election was held for the same length of time; that the following is a full, true and correct copy of the Notice so published and posted:
