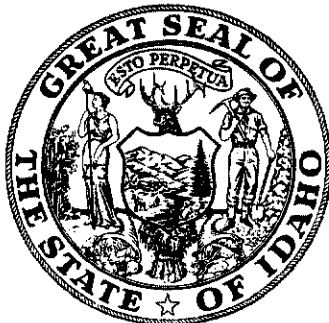

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. Name. The name of the corporation is PC Inc.

ARTICLE II. Purpose. The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE III. Duration. The period of duration of the corporation is perpetual.

ARTICLE IV. Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of Idaho is 298 N. Maple Grove Road, Boise, Idaho 83704. The name of the corporation's initial registered agent at such address is Patricia Haney Ocepek.

ARTICLE V. Stock. The corporation shall have the authority to issue 500,000 shares of stock which shares are without par value. All of these shares of the corporation are common shares; there are no preferred shares. Holders of these shares shall be entitled to one vote for each share of stock in his or her name at any time and all meetings of the stockholders of the corporation.

ARTICLE VI. Directors. The number of directors constituting the initial board of directors is two and all names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:
