

KNOW ALL MEN BY THESE PRESENTS:

- 1. The name of the corporation is Life is Huge! Inc.
- 2. The period of its duration is perpetual.
- 3. The purposes for which this corporation is formed are:
 - A. Promotion of group and/or individual entertainment acts.
- B.
