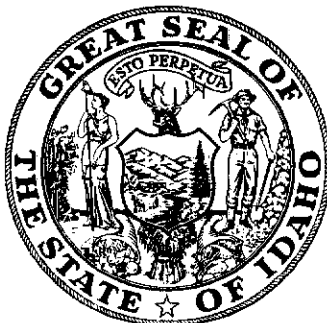

KNOW ALL MEN BY THESE PRESENTS:

1. The name of the corporation is Life is Huge! Inc.
2. The period of its duration is perpetual.
3. The purposes for which this corporation is formed are:
 - A. Promotion of group and/or individual entertainment acts.
 - B. To enter into, make, perform and carry out contracts of every sort and kind with any person, firm or corporation or other legal entity and to acquire and take over the good will, property, rights, franchises, options and assets of every kind and the liabilities of any person, firm, association, corporation or other legal entity either wholly or in part, and to pay for the same in cash, stocks or bonds of the corporation or otherwise.
 - C. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use and operate, real estate of all kinds, improved or unimproved, and any right or interest therein.
 - D. To manufacture, produce, buy, sell, trade and deal in any and all types and kinds of goods, machinery, products, merchandise and personal property of every class and description at wholesale or retail for and on account of the corporation or as manufacturer, broker, factor or agent for others.
 - E. For any and all other lawful business for which a corporation may be incorporated.
4. It shall have authority to issue 1,000 common shares, all of one class, with no par value.
