The undersigned persons, in order to form a corporation pursuant to the Idaho General Business Corporations Act (Idaho Code, § 30-1-1 et seq.) certify as follows:

ARTICLE I.

The name of this Corporation is: WAYMENT MANUFACTURING, INC.

ARTICLE II.

The period of existence and duration of the life of the Corporation shall be perpetual.

ARTICLE III.

The purposes and objects for which this Corporation is formed, and the general powers which this Corporation may exercise, are as follow:

- (a) To carry on and conduct the business of manufacturing machine components, and related business activities; and
- (b) To transact any and all lawful business for which a corporation may be incorporated in the State of Idaho under the General Business Corporations Act, I.C. § 30-1-1 et seq., and to exercise any and all such corporate powers provided by said Act.
