CERTIFICATE OF AMENDING ARTICLES OF INCORPORATION OF THE FULL GOSPEL PENTECOSTAL ASSEMBLY, OF IDAHO

KNOW ALL MEN BY THESE PRESENTS, That a regular meeting of the members and the Board of Trustees of The Full Gospel Pentecostal Assembly, of Idaho having been held in the city of Rupert, Minidoka County, Idaho, at the church building at the regular meeting place in said building, on the 25th day of October, 1952, at the hour of 8:00 o'clock P.M. of said day; that said meeting was held pursuant to Section 30-1103 Idaho Code, and which notice of said meeting was published for four issues in The Minidoka County News, commencing with the issue of September 25 and ending with the issue of October 16, 1952, and which said notice provided as follows, to-wit: "NOTICE is hereby given that a regular meeting of the members of The Full Gospel Pentecostal Assembly, of Idaho, being held in the city of Rupert, Minidoka County, Idaho, at the Church building at a regular meeting place in said building on the 25th day of October, 1952, at the hour of 8:00 o'clock P.M. in said meeting house.

This meeting is being held for the purpose of amending the Articles of Incorporation and particularly paragraph one thereof changing the name "The Full Gospel Pentecostal Assembly, of Idaho" to be known thereafter as "The First Pentecostal Church of Rupert, Idaho."

Article I.

That the name of said Corporation, by which it shall be known is "The First Pentecostal Church of Rupert, Idaho."

Said resolution wax duly passed, approved and adopted unanimously by the Board of Trustees and members of said corporation assembled at said meeting place in accordance with said notice.
