## ARTICLES OF INCORPORATION OF THE JACK WAITE EXTENSION?

KNOW ALL MEN BY THE PRESENTS, that we, B. F. Cooper of Murray, Idaho, George Schnellmann of Thompson, Montana and J. T. Ellarson of Murray, Idaho do hereby associate ourselves together for the purpose of forming a corporation and becoming a body corporate under the laws of the state of Idaho and we hereby declare and set forth:

FIRST. The name of this corporation is and shall be "The Jack Waite Extension"

SECOND. The purposes for which this corporation is formed are to work, operate, buy, sell, bond, locate, acquire, hold and deal in ores, mines mill sites, mining claims, mining and mineral property of every description and and easements incident thereto, within all the states and teritories of the United States; to carry on and conduct a general mining, smeltin, milling and reduction business; to purchase, acquire, hold, lease, erect and operate concentrating and other mills and plants for the working of ores and obtaining the metals therefrom, electric light and power plants for the purpose of mining and treating, and furnishing light and power in all the states and territories of the United States; to bond, buy, sell, lease, locate hold and operate ditches, flumes and water-rights, to construct, build, lease, buy, sell and operate rail roads, wagon roads, bridges, tramways and other means of transportation for transporting ores, mining and other materials in the states and territories of the United States; to own, buy, sell, lease and locate timber claims; to acquire, buy, sell, hold, bond, lease, dispose of, rent or mortgage real estate or personal property of every nature and description in the several states and territories of the United States; to buy, sell, loan and invest the proceeds of its capital stock, the profets arising from its mining or other business operations and any moneys arising from any other sources, in the capital stock of other mining, water or transportation companies, or in the bonds, mortgages, securities or liens of or against such other companies, and finally to do every thing consistent, proper and requisite with and for the carrying out of the objects and purposes aforesaid in the fullest and broadest sense in all the states and trritories of the United States.

THIRD. The principal place of business of this corporation shall be Murray. Idaho; but the board of directors shall bave the right and power to establish branch offices elsewhere in any of the states and territories of the United States.

FOURTH. This corporation shall exist for THE term of fifty years.

SIXTH. That the amount of capital stock of this corporation shall be one million dollars (\$1,000,000.00), divided into one million shares of the par value of one dollar (\$1.00) each.

This stock is declared to be fully paid apon the following conditions and consideration: This corporation pays six hundred and ten thousand (610,000) shares of its capital stock for the conveyance to it by the subscribers to the stock of said corporation of a group of mining claims, known as "The Independence Group", lying and being in Eagle Lining District, Shoshone county, state of Idaho and in an unorganized Mining District, Sanders county, state of Montana, hereafter to be conveyed to this corporation, when proper title is se-

cured and after the filing of these articles of incorporation in the states of Idaho and Montana I.E. with the secretaries of state of said States. The amount of capital stock, actualy subscribed and fully paid is six hundred and ten thousand (610,000) shares, in addition to three hundred and ninety thousand (390,000) shares (as one of the conditions of the sale of the property), fully paid and set aside for development and other beneficial purposes and called "TREASURY STOCK".
