## ARTICLES OF INCORPORATION OF

#### INLAND TECHNOLOGY OF IDAHO TRAINING CENTER, INC.

#### AN IDAHO BUSINESS CORPORATION

Pursuant to the provisions of the Idaho Business Corporations Act, the undersigned incorporator adopts the following Articles of Incorporation.

#### ARTICLE I

NAME OF CORPORATION. The name of the corporation is INLAND TECHNOLOGY OF IDAHO TRAINING CENTER, INC.

#### ARTICLE II

AUTHORIZED SHARES. The aggregate number of shares that the corporation shall have authority to issue is 100,000 shares of common stock. The par value for each such share of stock is: No Par Value.

#### ARTICLE VI

BOARD OF DIRECTORS' LIABILITY. No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for any act or omission as a director; provided that this article shall not eliminate the liability of a director for any act or omission for which elimination of liability is not permitted under the Idaho Corporation Act. No amendment to or repeal of this article shall apply to or have any effect on the liability of any director of the corporation for any act or omission that occurs prior to the effective date of such amendment or repeal. No amendment to the Idaho Corporation Act that further limits the acts or omissions for which elimination of liability is permitted shall affect the liability of a director of the corporation for any act or omission that occurs prior to the effective date of such amendment.

#### ARTICLE VII

BOARD OF DIRECTORS VACANCIES. Prior to the formal adoption of Bylaws for the corporation by the Directors as designated herein, any vacancy occurring in the board of directors, including any vacancy resulting from an increase in the number of directors, may be filled by the affirmative vote of a majority of the remaining directors, even if the number of directors remaining is less than a quorum of the board of directors, or by the sole remaining director. A director elected to fill a vacancy shall be elected for the unexpired term of the predecessor in office, if any. Following the adoption of Bylaws of the corporation the provisions of the Bylaws concerning the election of Directors shall control and have priority over this Article.

#### ARTICLE VII

PURPOSE. The purpose of this corporation is to provide instruction and training in the use and operation of computers, peripherals, related hardware, software, online services and other high and/or emerging technologies, independently and in conjunction with other individuals and businesses, including Inland Technology of Idaho, Inc. and Inland Technology of Arizona, Inc., and to engage in any other lawful purpose for which corporations may be established under the laws of the State of Idaho.
