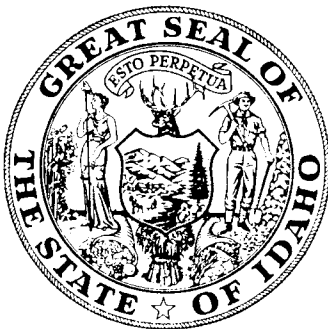
### CERTIFICATE OF AMENDMENT OF

ARTICLES OF AMENDMENT FOR  
NORTH RIDGE ESTATES WATER ASSOCIATION INC.

The undersigned Corporation hereby adopts the following Amendment to the original Articles of Incorporation of North Ridge Estates Water Association, Inc. in compliance with Idaho Code Section 30-1-61, as follows:

(a) The name of the Corporation is North Ridge Estates Water Association, Inc.

(b) That Article II(d) of the Articles of Incorporation shall be amended hereafter to delete the following word: "Lease."

(c) That Article V of the Articles of Incorporation shall be amended hereafter to delete the first sentence in said Article and substitute the following first sentence: "Any person who shall own or be a contract purchaser of any lot within said North Ridge Estates shall be a member of the Association, provided that only owners of improved lots shall be entitled to voting rights in the Association, and further provided that each owner of an improved lot shall be entitled to one vote for each lot owned or being purchased by said person in said North Ridge Estates, except that the owner or contract purchaser of Lot 8, Block 3 shall be entitled to two votes."

(c) These Amendments were adopted on July 17, 1992, by the Members of the Corporation at a Special Meeting of Members, wherein more than a quorum was present, by a vote of more than two thirds of all of the Members, voting in person or by proxy.
