- (c) $\underline{\text{To Transact Other Business}}$. To transact any and all other businesses for which limited partnerships may be formed under the laws of the State of Idaho.
- (d) To Act on Own Account or for Others. To accomplish any of the foregoing purposes for its own account or as nominee, agent or trustee for other individuals, partnerships, corporations or other entities.
- (e) <u>Registered Agent</u>. The name and address of the agent for service of process upon the Partnership shall be J. Reid Angus whose address is HC 72, Box 2224, Malta, Idaho 83342.

- 7. There is no agreement concerning the making of additional contributions by any limited partner, nor is there any agreement concerning the time when the contribution of any limited partner is to be returned.

The share of profits in the partnership business which each limited partner shall receive by reason of his contribution of capital is as follows: Ninety percent (90%) of the net profits of the partnership shall be divided among the Limited Partners in proportion to ther percentage ownership of the capital of the partnership.

- 9. A limited partner may not assign, encumber, give, pledge, transfer, devise, bequeath, or in any manner whatsoever dispose of all or any part of a partnership interst without complying with the terms of the partnership Buy-Out Agreement.
- 10. Additional limited partners may be admitted only upon the consent of all of the general partners.
- 11. There are no priorities between the limited partners as to contributions or as to compensation by way of income.
- 12. In the event of the death, retirement or withdrawal of any general partner, the partnership shall be dissolved, but the remaining partners shall have the right to continue the partnership business by purchasing the deeased partner's interest as provided in the Buy-Out Agreement unless the partnership is reformed as provided in the partnership agreement.
