X ARTICLES OF INCORPORATION OF THE X

KNOW ALL MEN BY THESE PRESENTS: That we, the under-
signed actual bona fide residents of the State of Idaho
have this day voluntarily associated ourselves together
for the purpose of forming a corporation under the laws
of the state of Idaho, and we hereby certify as follows,
to wit:

FIRST.-

That the name of the said corporation is the
"ADA LATERAL CANAL COMPANY", Limited.

SECOND.-

That the purposes for which this corporation is form-
ed are to own, operate, manage, control, repair, enlarge
and regulate a certain water or irrigation ditch or canal
and the water flowing therein and connected therewith, being
an extension of what is known as the New Dry Creek Ditch
commencing at the lower end of said New Dry Creek Ditch about
eleven miles westerly of Boise City, Ada County, Idaho,
and running thence in a general westerly direction down
Boise Valley, with all the powers incident thereto and
necessary to carry out said object.

THIRD.-

That the place where its principal place of business
is to be conducted or transacted shall be at the Pleasant
View School House in Ada County, Idaho, and its post office
address is Middleton, Canyon County, Idaho.

FOURTH.-

That the term for which it is to exist is fifty years
from and after the date of its incorporation.

FIFTH.-

That the number of its Directors shall be five and
