

KNOW ALL MEN BY THESE PRESENTS:

That we, JOHN JAMES NEILS, ROBERT G. NEILS, and JOSEPH R. NELSON, of Gallatin County, Montana, for the purpose of hereby creating a corporation under the laws of Montana, hereby certify and declare as follows:

I.

That the name of the corporation is "QUALITY BUILDERS, INC., OF BOZEMAN".

II.

That the period of its incorporation is perpetual.

III.

That the purpose or purposes for which the corporation is organized are:

- 1. To acquire by purchase, exchange, lease, or otherwise, and to own, hold, use, develop, operate, sell, assign, lease, transfer, convey, exchange, mortgage, grant security interests in, pledge, or otherwise dispose of or deal in and with, real and personal property of every class or description and rights and privileges therein wheresoever situate.
- 2. To exercise and possess all other rights, powers, and privileges granted by the laws of the state of Montana to corporations organized under the Montana Business Corporation Act.

IV.

The corporation shall have the power to create and issue fifty thousand (50,000) shares of common stock having no par value.

V.

No part of the authorized capital stock for which subscription has not been made shall be issued or sold except by giving the stockholders the preferential right to buy the same, at the price for which the corporation is willing to sell or issue, each stockholder to have the preferential right to buy in the proportion that the stock held by him bears to the outstanding stock.

VI.






