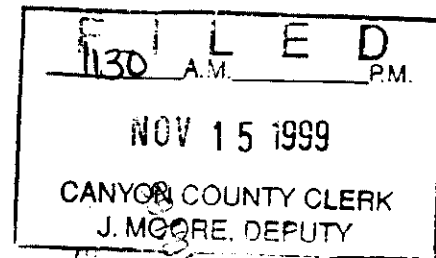

ORDER FOR PERMANENT INJUNCTION

This cause coming on for hearing according to notice on October 29, 1999, the Plaintiff being present and represented by counsel of record, the Defendant being present and represented pro-se, but not having filed a responsive pleading to Plaintiff's Petition For Permanent Injunction, and the court being advised, ORDERS:

1. Plaintiff's Petition For Permanent Injunction is granted.
2. Defendant Kimble Johnson, his agents and servants, and those in association or privity with him, are permanently enjoined from using the terms "Quality Services" or any other name confusingly similar to Plaintiff's licensed, registered Idaho Trademark "QualitreeTM" in connection with the promotion or provision of tree trimming and landscaping services.

ORDER FOR PERMANENT INJUNCTION

3. The Idaho Secretary of State is directed to cancel and strike Defendants' assumed name registration for "Quality Services - Trees & Landscaping".

4. Plaintiff's requests for damages, an accounting, and attorney's fees and ^{discretionary} costs are denied.

5. *The Plaintiff is prevailing party and entitled to mandatory costs.*
