

ARTICLES OF INCORPORATION

OF

COMMITTEE FOR FREE AFGHANISTAN OF IDAHO , INCORPORATED

In compliance with the requirements of the daynof Edaho Helling to nonprofit corporations and acts amendatory and supplemental thereto, including particulary Title 30, Chapter 3, Idaho code, the undersigned natural person, being of full age and a resident of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, does hereby as incorporator, adopt the following Articles of Incorporation and certify:

ARTICLE I

NAME

The name of the corporation is Committee for Free Afghanistan of Idaho, Incorporated, hereinafter called the "Corporation".

ARTICLE II

NONPROFIT CORPORATION

This Corporation is a nonprofit corporation.

ARTICLE III

PURPOSE AND POWERS OF THE CORPORATION

This Corporation is organized for exclusively charitable, educational, religious and/or scientific purposes. This Corporation shall be a nonprofit corporation. The purpose of the Corporation shall be to provide for the medical treatment and care of Afghan people inflicted by the brutalities of war currently in existence in the country of Afghanistan, and to bring said injured people into the state of Idaho for medical treatment donated by the various physicians, clinics and hospitals of this state. In addition, the purpose of this Corporation shall be to promote unity among the medical community of Idaho in assisting the injured and poverty-stricken people of Afghanistan, and to promote general awareness of the effect and conditions of the Afghanistan war in this state, and for this purpose to:

- (a) Coordinate with Committee for Free Afghanistan of Washington, D.C., in arranging transportation of certain injured Afghan people to Idaho, for treatment and care by the medical community of Idaho;
- (b) To set up a referral system of hospitals, doctors, nurses, and other medical related facilities who are willing to volunteer to assist those Afghan people brought to Idaho, for surgical or or other medical-related care;
- (c) After recuperation by Afghan people receiving medical attention in this state, to arrange for transporting those people and their families back to Pakistan with the assistance of the National Committee for Free Afghanistan of Washington, D.C.
- (d) To relate to the citizans of Idaho, the worthy efforts of our medical community in aiding the plight of the Afghanistan war through medical assistance given to their injured people;
- (e) To promote an educational awareness of the Afghan struggle through lectures, talks, films and other presentations to interested churches, schools, civic organisations, and the media;
- (f) To have and to exercise any and all powers, rights and privileges which a corporation organized under the laws for general nonprofit corporations in the State of Idaho by law may now or hereafter have or exercise.

ARTICLE IV

The duration of this Corporation shall be perpetual.

ARTICLE V

MEMBERSHIP

There shall be members in the Corporation.

ARTICLE VI

REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation shall be 196 S. First Ave. East, Middleton, ID 83644. The name of the initial registered agent shall be Liz Allen-Hodge at the aforementioned address.

ARTICLE VII

ARTICLE IX

TAX EXEMPT EXEMPTION PROVISIONS

The Corporation shall conduct its affairs at all times so as to qualify as:

- (1) A corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or successor provisions).
- (2) A corporation , contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or successor provisions).

The Corporation shall not, and shall have no part to, do any act in violation of provisions of law relating to such qualification.
